4:07	 Kendall Nagy, Director National Night Out, Thank you Idaho Office of Drug Policy for 13K PFS Grant Award, Teens & Substance Abuse Planning/Topics, SRO Drug Prevention Curricula & K9 Update 	 Drug Prevention Curricula Development, (Kendall, Harper) SRO K9 Stakeholder Meeting. Kendall was at the National Night Out (NNO) Kick-off meeting and provided over 115 people (at three NNO parties) Safe Rx Storage & Disposal Packets. Kendall reported a \$13,000 grant was awarded to us by the IODP. The funds will be used to purchase Cannabis Swabs to be used by SROs & Alcohol Compliance Check and Shoulder Tap operation implementations. The cannabis detection tests will be used to test vapes, e-cigarettes and devices found in schools. Kendall reported on our annual teens and substance abuse education events. Kendall is asking for speakers and wants to put together a work group to organize the teens and substance abuse planning. Suggested topics for the series included: Kratom, Stigma Reduction, vaping and <u>The First Day</u> Film. In partnership with Meridian Community Development we will have Rx Safe Disposal Packets in three locations at City Hall for National Overdose Awareness Day Aug 31. The packets will be available the 26th- Sept. 6 or while supplies last. SRO drug prevention curriculua: BPD and ACSO may be interested in implementing new SRO drug prevention curricula across departments and in collaboration with MADC. A tentative rollout is set for spring 2020. Kendall is part of the Treasure Valley Partnership Opioid planning group and they were able to create an addendum to a provider tool kit created by the state workgroup. Hopefully this tool

		 will be available for the coalition to help disseminate soon. In addition they are working on an educator toolkit we will help disseminate once completed. K-9 Sergeant Fraiser reported on issues coming up regarding current drug dogs not being able to tell the difference between different cannabis derivatives (CBD, hemp, marijuana). This is going to be a huge issue if and when Hemp becomes legal to grow in Idaho. Going forward, the current K9s will be fazed out and new dogs will no longer be trained to alert on cannabis.
4:25	 Sector Representatives, Expanding Prevention Strategies Within the 12 Sectors Brandon, Law Enforcement Sector Rep Results of CBD Compliance Checks Dawn, School Sector Rep Cannabis Swab & New Data Collection 	 Sergeant Fraiser reported samples of CBD and hemp oil have been purchased from retailers in Meridian. The samples were sent out of state, tested and compared to the content labeling. The results found that they had undetectable levels of THC, .01% which was consistent with what the retailer said regarding these CBD oil products. The majority of the samples tested had less CBD than the labeled said. Dawn reported on cannabis testing in schools via 400 swabs received from MPD/MADC which will be used to test e-cigarettes and other vape devices and paraphernalia. New this year,
	 Mary Liz, Faith Sector Rep MADC Letter for Faith Leaders 	 WASD's annual data collection for youth drug use will be broken into specific drugs to help provide more accurate data on what drugs youth are using. Mary Liz reported as sending out a letter to all churches to inform them that MADC is willing and able to speak at their establishments in order to speak on drug prevention. This letter will be shared with all sector reps. If they would like to use it as well. MADC can send the letters once the contacts have been established.
