4:07	Kendall Nagy, Director: City Council	Update from MADC to City Council (10/8)– started with the data sources that help determine MADC's prevention strategies. It's important that we look at local and state level data in addition to the coalition members focus desires. There has been a lot of growth the last 5 years. A single page snapshot of the MADC work in the community shows we participated in 72 events/programs last year reaching 21,000+ Meridian community members. As suggested in the MADC meeting, we highlighted the video made with Zach Telford regarding his Natural High. We then discussed the expanding state and local partnerships that MADC has established. Looking at the last fiscal year we had over 28k in mini grant awards. Through these mini grants we have been able to sustain our prevention strategies, while not competing against other coalitions across the state to receive the larger federal grants. MADC presentation ended with two quotes regarding MADC: "Coalitions like yours are crucial to prevention education and we appreciate your hard work. 	Treasure Valley Youth Safety Summit	Treasure Valley Youth Safety Summit Report is complete: There were over 130 youth that were selected to attend this annual event. Kendall presented on substance abuse prevention talking about reducing stigma, refusal skills, most commonly abused substances among youth and actionable items to prevent substance abuse. 77 people responded to the optional survey. (see attached report for more information regarding the following) Drug related questions from survey: #7 Is it safe to smoke marijuana regularly? Looking at the indicator of

	perception of harm regarding marijuana, which has gone down over the last three years. #8 In the last 12 months, I have been at a party where other kids my age were consuming one or more of the following: Alcohol 32%, Marijuana 22%, Rx Drugs 9% and None 68% There was a spot that youth could put in ' other ' and the responses were: cocaine, shrooms, vaping and acid. #9 If I choose to use an impairing substance, the following are easily accessible: Alcohol 82%, Marijuana 46% and Rx 58%. #15 In the last 12 months, I have driven a car after consuming an impairing substance, 5% said yes. #16 The impairing substance(s) were one or more of the following: Alcohol 75%, Marijuana 75% and Rx 0%. #17 In the past 12 months I have ridden in a car whose driver had been consuming an impairing substance: 28% Yes. #18 The impairing substance(s) were one or more of the following: Alcohol 72%, Marijuana 50% and Rx 13%.
	David: Marijuana in California. Youth were getting it from their parents. Confusion on weather kids should tell on other kids if they bring marijuana to school because it's legal in California. Kids are scared to question adults because adults are making poor choices.
Meridian Police Department Opioid Report	Another source of data – in our participation with the Treasure Valley Partnership Opioid Workgroup, we have looked at Opioid statistics the last two years. Looking at the same time period of 2018 as 2019 there has been a 19% decrease in opioid related reports. The majority of these cases occur at a residence or during a traffic stop and involve an arrest. Another data point included in the report from the Bureau of Vital Records and Health Statistics is drug induced deaths by city of residence with one or more drugs reported and opioid-involved deaths. Data for Meridian shows in 9 out of 10 deaths opioids were present. This data helps guide our selection of prevention strategies.
Boys & Girls Club Family Dinner Life Skills	Events: We joined Boys and Girls Club for Family Dinner Night. SRO's attended. Officer York played music. MADC had the Natural High Booth setup so kids could get their picture and have conversations about natural highs. We had 95 prevention conversations. Kendall taught in the Life Skills Classes at Lewis & Clark reaching 67 youth.

Brandon: 5 K9 demonstrations scheduled for Red Ribbon Week, one demonstration for the Public Safety Day. Also, there has been an increase of information in the media regarding Hound Labs Cannabis breathalyzer. They are a company in California that created a device that will tell the officer if there are specific markers of marijuana on a person's breath. It does not prove impairment. The company won't speak to what markers, which is problematic for court purposes. The news stories talk about how exciting this is for Law Enforcement, but there aren't interviews with Law Enforcement regarding this product. It's not what it seems, zero scientific data that shows the quantitative data actually shows anything. This machine doesn't show that they are
	impaired. There probably is some kind of promise there but it's not here yet.

	\$110 per student. Currently WASD uses the Safe and Drug Free School fund for this, but they run out before the
	end of the year having to turn away students that request the assessment.
